

REGULATION 2017

1. All persons on board the boat must be entered in the tournament.
2. The decision of "THE JUDGE OF SCALE" and, in its case, "THE OFFICIAL COMMITTEE" that is integrated for the purposes of the Championship, is not subject to appeal. "THE OFFICIAL COMMITTEE" may be represented by the "Championship Director" or by the "Operational Coordinator of the Championship" or the representatives of the latter.
3. It is compulsory for all fishermen to have their individual fishing permit in force.
4. It is the obligation of the participants to carefully know the Bases and Regulations and to be present at the meeting of captains or if not the participant agrees to them and any changes made to the present regulation.
5. The fishing equipment will be free as well as the line class.
6. The rules of the IGFA (International Game Fish Associations) are valid in this tournament.
7. It will be the responsibility of each participant to bring their catch to be presented to the scale and after submitting them to the register will be returned to the fishermen.
8. The Scale Judge will give the fisherman his proof of weighing and it will be the responsibility of the fisherman to verify at the moment that the information, the equipment number and the time of the weighing, as well as the weight are correct, the fisher accepts that all The information of the same is correct so it will not be accepted later modifications, only in case of system error will be able to modify the results, for which the fisherman must present the original copy of the weighing in question.
9. Once the fish bites the bait and hooks, it must work and approach the boat without further aid than the reel, cane and line. No one will be able to help the fisherman while working the fish. In addition, they must use a single cane per fisherman enrolled in the tournament.
10. No courtesy species are weighed and only one species per category is weighed according to the one chosen by the fisherman. For the award, the weight of the fish will be taken into account and in case of a tie it will be decided in favor of the fisherman who first registered his prey in time before "THE JUDGE OF SCALE".
11. For the registration of the catches, the contestants must appear personally before "THE JUDGE OF SCALE" showing their bracelet with their registration number. It is forbidden to present catches arriving at the weighing area by land even by force majeure or unforeseeable circumstances.
12. The departure of boats will be at 06:00. The scale will open from 12:00 hours. "THE JUDGE OF SCALE" will not receive any piece after the scale has closed at 16:00 hours of the day of the tournament. There will be an official clock in a place visible to all by which the judge and the contestants will be governed.
13. "THE OFFICIAL COMMITTEE" is not responsible for any accidents that competitors have before, during and after the tournament, therefore, the competitors with their boats will enter the competition at their own risk.
14. Although there are personnel to help transfer the capture of the boat to the scale, the fisherman will be solely responsible for the presentation of the catch in good conditions before "THE JUDGE OF SCALE".
15. All participants must have the digital file of a video and two photos of the catches presented in scale, the video files will have to contain the moment of fight and capture of the species showing at the same time the key or signal previously Assigned in the inscription or meeting of captains, this in case of any official protest or even for the simple doubt of "THE JUDGE OF SCALE", the files will be obligatorily requested and who in turn will check the veracity of the same and in its In case of a fault.
16. Competitors who obtain the 1st. to 3rd. place in the category of surface and bottom in adults, in addition to the first place of the child category in bottom and surface, are obliged to present to "THE OFFICIAL COMMITTEE" of the tournament, the video and the photos already mentioned, which will be reviewed later 30 minutes after the last row fisher has registered his catch; the names of the competitors that will have to submit files in the review table will be announced 5 minutes after the weighing is closed, so that all participants who have registered weighing are obliged to remain in the registration area, since those who do not comply with this requirement they will be disqualified, that is to say without right to prizes and (in the case of children) videos may be received up to the next two best positioned places) (2nd and 3rd) this with

prior mandatory revision of their corresponding digital files and will have an extra time of up to 15 minutes after the 30 minutes of the previous video (1st, 2nd and 3rd or 1st child) has been completed. Otherwise, they will also be without prizes and punctuation and the corresponding prize will be declared deserted.

17. The only two persons who may be aboard the boat without having to be necessarily enrolled in the tournament will be the skipper of the boat if he is not going to fish and is hired by the participants. The other person who does not necessarily have to be enrolled in the tournament if the participants of a
18. Any fisherman who detects any irregularity committed by the participants of other boats, must report it personally with the evidence that he has to bear his free written statement and signed no later than 30 minutes after the closing of the boat by the interested party with a deposit Of \$ 1,500 pesos in cash and "THE JUDGE OF SCALE" and / or "THE OFFICIAL COMMITTEE" that for that purpose is constituted, will have the obligation to carry out the pertinent investigations to qualify And in its case to sanction the lack before the award ceremony. In case the complaint is appropriate, the deposit will be returned. In the case of verification of the digital files described above, they may be present in the verification carried out, "THE JUDGE OF SCALE" and, where appropriate, "THE OFFICIAL COMMITTEE" or a representative, the complainant and / or complainant and the fisherman of the species in question.
19. The content of the present regulation is enunciative but not limiting reason why what is not contemplated in the same, will be decided by the main judge according to its criterion and the one of the organizing committee.
20. By order of the Ministry of Communications and Transportation (S.C.T), as well as for your own safety, it is mandatory to bring safety equipment, VHF radio on and tuned to the previously assigned frequency on board the vessel, which is authorized for all tournaments. Participants should refrain from misusing radiocommunication equipment on the understanding that the person (s) identified as misusing the radio will be severely sanctioned, both by the S.C.T. As per the direction of the tournament.
21. The participant who is caught committing any lack of those contemplated as a reason for disqualification will automatically be left out of the competition he, the members of his team and all the catches that would have registered.
22. The disqualification may be decreed by "THE JUDGE OF SCALE" and / or by "THE OFFICIAL COMMITTEE", or in his absence by who represents them.

WILL BE DISQUALIFICATION:

- a) To contravene the bases and rules of the tournament and provisions written in this text.
- b) Rest the cane on the edge of the boat when the fish is working.
- c) Present the fish in a state of decomposition or with signs of being frozen.
- d) Allow fishing in the boat to persons not registered in the tournament, this infraction will cause to be disqualified all the species that had been captured in the boat in which the infraction was committed, including those already registered, the contestant or registered contestants on that boat would be disqualified and automatically out of competition.
- e) To fish by free hand, that is to say, without cane and reel, symbol of the sport fisherman, or with electric spools.
- f) Present unsportsmanlike conduct.
- g) To present to the scale some fish not captured by the same fisherman, whether it has been fished by a companion of the boat, by persons not registered in the tournament, or acquired in any of its forms.
- h) Other causes not contemplated, that by their seriousness in the judgment of "THE JUDGE OF SCALE" and / or "THE OFFICIAL COMMITTEE", go against the sporting spirit of fishing.
- i) By complaint.
